The ongoing cash benefit serves the purpose of subsidizing your housing rent (rent subsidy) and is subject to the aforementioned prerequisites, which must be met for the period in which the rent subsidy is paid. The German Sport University Cologne must be informed immediately in writing of any changes with regard to the aforementioned prerequisites. If the current monetary payment is used inappropriately or if the aforementioned prerequisites are not met, the German Sport University Cologne is entitled to revoke the rent subsidy in accordance with the Administrative Procedure Act (VwVfG).

The DSHS hereby grants the applicant a monthly allowance of 250 euros, as the rent exceeds the minimum limit of 300 euros per month. The grant period is a maximum of two semesters. Reapplication is possible, provided that the total funding period of one year is not exceeded. The GSU hereby grants the applicant a monthly allowance in the amount stated below. Payment will be made to the bank account specified under point 3. Any costs incurred for the transfer shall be borne by the person receiving the grant. The grant may only be used as a subsidy towards the rental costs. If the preconditions for the granting of the rent subsidy, which are formulated in the ancillary conditions attached as an appendix, cease to apply, the excess grant received, if any, must be repaid to the GSU without delay. The grant shall cease to apply if the applicant ceases to be a regular student at the GSU Cologne. The person receiving the grant.
