



Call for proposals for postdoctoral research funding (Call No. 4)

Research funds of the German Sport University (DSHS)

Aim of the grant

Call No. 4 is part of the research funding schemes of the German Sport University (DSHS) for young scientist. With this call young scientists should be supported in their postdoctoral period. They should be given the possibility to focus on their research profile and to expand their scientific independency. Excellent young scientists shall be given a career opportunity by funding their own major research project (or subproject) at the German Sport University. Therefore, the German Sport University Cologne promotes innovative research ideas with relevance for basic and/or applied sciences in the field of sport sciences.

Financial modalities

In this call, **up to 70,000 Euro for a period up to 2 years** can be requested with an individual application (no group applications). A grant from the research funding schemes of the university may be the only source of funding for the project, but can also be used as additional financing. The funds can be spent on financing of the researcher's own position (up to 50% principle investigator position (WMA)), personnel costs (SHK/WHK/WHF/WMA) or on equipment and travel expenses. Pre-condition for funding is a contribution of the Institute/Department of at least 25% of total project costs. An award will be made if the university budget allows its implementation and if the university has enough resources in the award year.

Application process

PostDocs of the German Sport University and external national or international PostDocs up to 6 years after completion of their PhD (parental leave is credited), aiming a career in science, are eligible to apply. Only proposals from individuals are eligible. Each person can only hand in one proposal.

The proposal has to include the outline points of the application form (see appendix) including the documents referred to therein as an attachment.

Applications can be written in German or English. Complete application documents should be handed in electronically (by e-mail, max. 5 MB) as **one pdf** document to the Department of Research and Young Academics (Dr. Nana Ueffing, ueffing@dshs-koeln.de, telephone -4608).

Review process and approval

In-house and external scientific reviewers are involved in the review process. Core reviewing criteria are:

- Individual-related aspects (e.g. previous research achievements, career opportunities)
- Relevance of the topic
- Quality and feasibility of the proposal tasks
- Adequacy of methods and models
- Relation outcome/costs

Approvals are estimated to be given in July 2017. It is intended to open the call twice in 2017.

Final report

For projects with a time span of more than one year, an interim report has to be submitted after half time of the project. Results of the project should be handed in as a final report and a publication



(submitted or published high-ranking expert contribution) to the Department of Research and Young Academics six months after ending of the funding period. In addition, a contribution with selected results has to be submitted to the universities newspaper *Kurier* or science magazine IMPULSE. Projects should be added to the research information system (FIS) of the German Sport University.

Deadline is 20 March 2017.
