The GSU wants to build up and implement a systematic qualification and counseling offer for Post Docs to particularly support young academics. The Referent will design the content of the existing concept for post doc qualification at GSU further and develop and implement practical measures to structurize the post doc phase and the multidisciplinary qualification and (career-)counseling of post docs. Particular attention is to be paid to the qualification of female young academics and the management of academic career and family. The Referent will strongly cooperate with the department Research, Scientific Staff and Young Academics and the GSU Human Resources department supported by a student research assistant.

#### **Your tasks**

- Develop and elaborate the concept for post doc qualification in cooperation with the relevant committees and staff, especially the department Research, Scientific Staff and Young Academics and the GSU Human Resources department
- Implementation of the issues equal treatment and management of academic career and family in the post doc concept and in the resulting qualification and counseling offers in cooperation with the GSU equal opportunity commissioner
- Implementation of the post doc qualification concept by
  - Installing and developing cooperations with internal and external commissions, e.g. human resources development of GSU and other universities
  - Installing a pool of mentoring consultants and of courses for multidisciplinary qualification
  - Supporting the consultants and the courses
  - Evaluating the concept by conducting post doc surveys on target group specific development and adaptation of the measures
- Teaching in the multidisciplinary courses for post doc qualification
- Participating in the conception, implementation and further development of the HRS4R-Strategy in the frame of the European Charta for researchers and the code of conduct for hiring researchers ( EU-Charta & Code)
- Developing, compiling and distributing information on post doc and career issues

- Doctorate
- Experience in academic work (own research projects, third-party funds, publications)
- Very good knowledge of university structures and – culture and the requirements of an academic career, particularly the the post doc phase
- Proved knowledge and experience in at least one of the following areas: Human Resources development, counseling of researchers, equal treatment and management of family and academic career
- Very good communication and organization skills
- Structured and responsible manner of working and strong ability to work in a team.
- Fluent in spoken and written German and English
