Dear reader,

After three years of collaboration and after three joint seminar linked with three Brussels based workshops the HOMER now reaches its preliminary finish. After exploring the Hague summit 1969, the Maastricht summit 1991 and the summits that are linked with the Lisbon Treaty we have a deepened the understanding of European narratives and the linkage of narratives and summits. Seminars with students in Cologne and Maastricht as well as meetings with experts in Brussels provided the frame for indepth debates and intense research on relevant material and sources (newspaper articles, archival material, memoirs, academic interpretations, interviews etc.). At the end the students presented their findings and discussed the offers and constraints of narratives on the European Union. This final newsletter sums-up the HO-MER project and presents an overview on both its achievements and constraints. Though not all original targets have been achieved the project as a whole can be considered as

an asset to existing teaching approaches on European integration. The core team consisting of Wolfgang Wessels, Sophie Vanhoonacker, Kiran Patel and Juergen Mittag, substantially supported by Hartmut Marhold and Wilfried Loth, is looking forward to continue these activities in the next years. In order to realise this ambition, critical comments and further communications are appreciated.

SUMMARY OF THE PROJECT **DESCRIPTION OF THE IMPLEMENTED ACTIVITIES:**

In order to contribute to the project's main target providing orientation on European memory by exploring the

role of the European Council and its summits in view of narratives of European integration eight major activities have been implemented.

• The first joined seminar was dedicated to The Hague Summit of 1969. Three joint sessions between April and July 2015 and addi-

IMPACT, VISIBILITY AND DISSEMINATION

The general interest on the HOMER project was remarkable. When the seminars were announced a significant number of students expressed their interests to participate in one of the three HOMER joint seminars. However, the number of students that finally decided to formally register for the seminars was smaller. The first joint seminar was attended by 27 students who successfully finished the seminar, the second by 25 students and the third by 21 students. The evaluation of the HOMER seminar by the students indicated in general a very positive reception highlighting primarily the "group work with students from other universities" and new approaches to the "analysis of narratives" and the "discussion with experts". The evaluation of the third seminar showed this in detail: Being asked for the reasons why they decided to participate in the HOMER project 41 % of the students (of the third joint seminar) anticipated more and detailed information about the Lisbon Treaty while just 29 % of students were primarily interested in the different European views and narratives. Nearly all of them (94 %) regarded their respective expectations as fulfilled. 52 % of the students stated that the interactions with different academics were most helpful; others also mentioned the introduction in research or narratives as useful. However, student's presentations were seen critically by nearly half of the participants as critically (47%). Generally positively rated (88 %) was the support and the literature provided by experts and teachers. Several students highlighted in this context the video material that has been provided. Yet 12 % of the students were critical and wished to get more detailed information about alternative ways of finding literature for their

studies. 76 % of the participants evaluated the interaction with students from different universities as positive. "Something that should be done more often" is a typical statement that has been given in this perspective. Although the exchange in general was considered as encouraging, there was also criticism linked to the "coordination of discussion", which "took too long" or the "different level of knowledge about politics and the EU", which influenced the quality of contributions. Improvements have also been proposed regarding the number of experts (29%) or the implementation of additional meetings (17%) between Brussels and the final seminar in order to get a more detailed feedback on the research that

has been carried out in the meantime. Other critical comments were attributed to the "communication" and "pre-planning of the sessions". The overall assessment at the end of the evaluation of the third as well as the first and second seminar presented remarks such as "great extracurricular seminar", "interesting seminar", "nice atmosphere", "I would always chose to participate again", "thanks for this opportunity (...) to deepening our knowledge" that underline the relevance of the HOMER project and the approach.

By means of regular participation the project benefitted from proposals and critical comments of the members of advisory board (Loth, Marhold). As an overall assessment on the project the two experts stated (... quote Marhold, Loth). The newsletter and the regularly updated webpage ensured awareness and responsiveness in terms of visibility. The newsletter was distributed to different networks while the webpage obtained a regular attendance of around 500 hits a week (counter).

Dissemination in its qualitative dimension primarily was secured by the students that successfully participated in the HOMER program. The certificate issued by all four professors is considered helpful in view of professional job perspectives; a deep impact left the ceremony in which the students obtained their certificates from politicians, predominantly the one by Martin Schulz, at that time president of the European Parliament.

Dissemination in a quantitative dimension was achieved by the public lectures that attracted an attendance of around 30 to 60 people including students as well as citizens from Cologne and Maastricht.

TEAM INVOLVED IN THE PROJECT AND THEIR ROLE

The HOMER project was jointly organised by the steering committee composed of Wolfgang Wessels, Sophie Vanhoonacker, Kiran Patel, and Jürgen Mittag. Communication among the project team was ensured by regular participation of the academics prior and after the joint seminars and workshops. Prof. Wolfgang Wessels contributed to the project also after his formal retirement in 2016. The project coordinator took part in all joint sessions of the seminars and the workshops alike (with the exception of the second workshop in Brussels). Additional communication was ensured by bi- or trilateral meetings of the core team and by the researchers

entrusted with the project.

The advisory board of the project has experienced some changes. Due to her commitment at the European University Institute in Florence Brigid Laffan was not able to attend the sessions of HOMER project. Philippe de Schoutheete who accompanied the first HOMER activities unfortunately passed away in September 2016. The two other members of the advisory board, Prof. Wilfried Loth and Prof. Hartmut Marhold took regularly part in the joint seminars and met also on a regular base after each joint seminar with the HOMER steering committee.

In order to ensure proper coordination and support for the students Johannes Müller-Gomez at the University of Cologne and Dr. Till Müller-Schoell and Diana Wendland at German Sport University were employed (partly) at the respective universities.







PUBLICATIONS

Ten issues of the HOMER-Newsletter have been published on the website of the project (www.eu-homer.eu). The regularly updated website informs about all activities of the project so far and ensures sustainability.
