
Latest News

Intake 7: 25 Participants to start on September 8th

For the application process of the 7th intake of the Master of Olympic Studies, the programme management team of the OSC Cologne received a total of 65 applications from prospective students worldwide.

The application process saw the highest interest in the study programme to-date, demonstrating its renowned international reputation. The admissions board had to undertake a detailed evaluation process and selected 25 high-profile participants. As in previous intakes, the group of participants is very international. The participants come from 20 different countries on 4 continents: Africa (5), Asia (10), The Americas (4) and Europe (6).

The M.A. Olympic Studies community is greatly anticipating the commencement of the new participants' studies and welcoming them onto the programme in person.



It is scheduled that the 7th intake's first module will take place from 8-14 September 2019 and will once again be launched with an official opening ceremony at the German Sport University Cologne (Sunday evening, 8th September 2019).

New M.A. OS Lecturer Frank van Eekeren: Governance, Policy and Olympic Organisations

We are delighted to announce that Prof. Frank van Eekeren from Utrecht University School of Governance, the Netherlands, has agreed to assume the teaching responsibilities for the M.A. Olympic Studies' module 'Governance, Policy and Olympic Organisations'.

Amongst others, Prof. van Eekeren assumes the roles of Assistant Professor in Utrecht and, as of 1st

August 2019, also Professor Applied Sciences 'Value of Sport' in The Hague. In addition to this, he is currently managing a research focus area Sport & Society and holds the expert position in the steering committee of the new Code of Good Governance in Sport in the Netherlands. He has earned a high international reputation within the academic community and collaborates with numerous universities in the role of Research Associate. With his expertise in the fields of both governance, more broadly, and sports governance, in particular, we are sure that everyone within the M.A. Olympic Studies community will greatly benefit from his future collaboration.

Renewed IOC Commission Appointments for M.A. OS Professors

Appointments to the commissions of the International Olympic Committee are decided annually by the IOC President. For 2019, Dr. Bach once again nominated Prof. Norbert Müller for the Culture and Olympic Heritage Commission and Prof. Wassong for the Olympic Education Commission. At both commissions, the profile of the M.A. Olympic Studies is highly valued and the commissions'

members follow the development of the study programme with interest. This is important as the IOC has already decided to further support the programme financially alongside supporting student participation through the awarding of Olympic Solidarity scholarships.

Meeting with IOC-President Thomas Bach

On 8th March 2019, a meeting between Dr. Bach and Prof. Wassong took place in Lausanne. In a one-hour talk, Prof. Wassong first informed the President of the IOC about the research and teaching priorities of the Centre for Olympic Studies at the German Sport University Cologne.

Dr. Bach showed great interest in the ongoing research project on the foundation of the IOC Athletes' Commission and the analysis of its initiatives between 1981 and 2000. Prof. Wassong also reported on the development of the M.A. Olympic Studies, which has been supported by the IOC financially from central funds and through the scholarship system of Olympic Solidarity since 2012.

Dr. Bach was very positive about the report and considers the programme and its ongoing support from the IOC as highly valuable in the further development of Olympic education.

The meeting also served as an opportunity to exchange views on the reorientation of the International Pierre de Coubertin Committee (CIPC), an organization officially recognized by the IOC. Prof. Wassong has been the President of the CIPC since January 2018.

Thus, this constituted his first opportunity in this role to inform the IOC President about the projects during the initial four-year term. Dr. Bach attributed great

importance to the CIPC's publishing, exhibition and teaching projects for the Olympic Movement and, in particular, supports the intention of the CIPC to analyse the relevance of Coubertin's ideas for today's profile of the Olympic Movement.

International Pierre de Coubertin Committee



On 9th and 10th March 2019, the annual general assembly and the board meeting of the International Pierre de Coubertin Committee (CIPC) took place in Lausanne. Therein, Prof. Wassong reported on the activities and projects that he had initiated and already realized in his first year as President of the CIPC.

Of particular interest for the members, who had travelled to Lausanne from all continents, were the working report on the completely reinvented website in terms of content and graphic design, the involvement of the CIPC in the editorial consortium of the international journal 'Diagoras: International Academic Journal on Olympic Studies' and preparations for the Pierre de Coubertin Youth Forum to be held in Mâcon in 2019.

At the meeting of the Executive Board, Ms. Katarzyna Deberny (NOK Poland) was elected as new member of the Board, a new scholarship programme developed and the 2018 annual report for the IOC adopted. The new website was launched just recently on 23rd June 2019, the Olympic Day.

Hinkelien Schreuder: The Role of Athletes in Olympic Governance

Hinkelien Schreuder, former gold and silver Olympic medallist in swimming (2008 and 2012) and current President of the Dutch National Olympic Committee's (NOC) Athletes' Commission (AC), was invited to the GSU to hold a presentation on the role of athletes within Olympic governance on 11th January 2019.

The highly engaging presentation was held during the regular lectures of the GSU's M.A. International Sport Development and Politics programme and implemented an interactive approach, encouraging students to participate in activities and stimulating discussions.

Shinning a light on the roles and responsibilities of ACs, Ms. Schreuder spoke of how the Dutch AC both works with the Dutch NOC and broader sports system to deliver on its agenda and represent athletes in sport political decisions. In addition to this, she outlined her personal athlete's story and how she transitioned into sports governance.

Questions were raised within the group discussion on

the topics of, amongst others, the feasibility of dual careers for athletes, the financing structure and independence of an AC, and the views of athletes (also the position of the IOC's AC) on the recent Russian doping scandal; with Ms. Schreuder providing numerous real-world examples to help facilitate understanding.


On 20th May 2019, Luís Henrique Rolim Silva presented and defended his PhD thesis titled 'Formation of an Olympic Nation in the Persian Gulf: sociocultural history of sport in Qatar, 1948 – 1984' at the GSU Cologne. Dr. Rolim Silva, who is from Porto Alegre, Brazil, used his work experience and contacts in Qatar to present an interesting portrait of the young Olympic Nation within his research. The thesis was supervised by Prof. Wassong and Prof. Thierry Zintz (UC Louvain). The GSU's OSC congratulates Dr. Rolim Silva on his excellent academic achievement.

IJHS: Special Issue on Sport Development and Olympic Studies

Prof. Michael Heine (School of Kinesiology at Western University, London, Canada), Prof. Rob Hess (College of Sport and Exercise Science and the Institute of Sport and Health at Victoria University, Melbourne, Australia) and Prof. Wassong (Olympic Studies Centre of the German Sport University Cologne) recently finalised an ambitious publishing project: The editing of a special issue of the prestigious journal 'The International Journal of the History of Sport'.

The corresponding title was <u>'Sport Development and Olympic Studies: Past, Present and Future'</u> and the publication's contents included a highly interesting collection of research papers submitted by scholars from the three respective universities. The field of research in Olympic

Studies is undoubtedly very broad and, to assure thematic coherence, the studies assembled for this collection focused on the analysis of processes of continuity, transformation and development across four areas: sport institutions and their policies; commissions within and policies of governing bodies of



sports; legacy discussions; and of sport events within the Summer/Winter Olympic Games transformed into political and cultural spectacles. Without doubt, all research articles published in this special issue are valuable sources for the participants of the M.A. Olympic Studies.

Module on Media and Commercialisation of the Olympic Games - M.A. Olympic Studies



From 17th to 23rd March 2019, CEO-UAB welcomed 21 students to the University from the M.A. Olympic Studies, coordinated by the OSC Cologne.

MOOC Olympic Games and the Media

CEO-UAB continues to offer the massive open online course The Olympic Games and the Media to all those interested in learning on the media perspective of the Olympics. The 5-week course has been offered ever since June 2014 in English, with subtitles in Spanish through the Coursera platform. Thus far, the course has been undertaken by students from more than 143 countries.

Dr. Susannah Stevens Appointed NZCOS Co-Director

The 2019 academic year in New Zealand is well underway. A key development for this year is the appointment of Dr. Susannah Stevens as co-director of the NZCOS.

Dr. Stevens has been heavily involved in Olympic Studies since graduating with a Bachelor's degree over 12 years ago.

Involvement with the Global Foundation for Community Health

As reported last time, the NZCOS is an active 'player' in the 'Global Foundation for Community Health' (GFH) where the work of the GCH has become globally significant as it collaborates with UNESCO in working towards achieving the United Nations 17 Sustainable Goals.

The Foundation for Global Community Health (GCH) focuses on utilizing the 'Whole School, Whole Community, Whole Child' framework for the development of child wellbeing. This framework was developed by the 'Centers for Disease Control and Prevention' (USA).

The GCH has implemented a school-based well-being programme, currently reaching 2-3 million children daily in 70+ countries throughout the world. A key strategy of the GCH is building international networks, and in cooperation with an international team of advisers,

GCH has emerged as a key global player for delivering a research-based locally focused and globally scalable digital well-being platform to the world's 1.9 billion young people.

In this delivery, GCH has developed an impressive network of scholars and community leaders – see website www.gchfoundation.org. This network delivers the United Nations' Sustainable Development Goals (SDG) on a unified platform utilizing the CDC's Coordinated School Health framework via Labs, online GCH support platform, and in the process establishing a SDG School Index overseen by the United Nations. What is particularly relevant is that the work of the GCH is consistent with the philosophy of Olympism where holism and the balanced development of young people is a priority.

GCH Promotion and NZCOS International Activities

Dr. Stevens and Prof. Culpan from the NZCOS are involved in the GCH where they are promoting the importance of Olympism within physical education as an avenue to the achievement of individual and collective well-being.

An example of this work is Prof. Culpan's recent visit to China at the 'World Congress on Teaching Learning, and Curriculum in Physical Education', where he was an invited speaker. Both Dr. Stevens and Prof. Culpan have

also received invites to South Africa in October and the Philippines in November. Prof. Culpan has also been invited to a symposium 'think tank' in Brazil in early 2020.

Further to this the NZCOS will be hosting the founding leader of the GCH, Professor Dr. Mingkai Chin, at the University of Canterbury in July.

Closing Message from the NZCOS

The NZCOS (University of Canterbury) continues to collaborate with the GSU and the Autonomous University of Barcelona in the imminent publishing of the third issue of 'Diagoras: International Academic Journal on Olympic Studies'. Furthermore, the student exchange scheme between the GSU and the University of Canterbury is due to get underway later in 2019.

In closing the NZCOS values the collaborations with

Prof. Wassong and the staff of the GSU as it helps us stay connected to scholars in the field and in so doing contribute to the developing global network of Olympic studies.

Graduates

Kobus (Charl J.) Roux

Kobus Roux (South Africa) enrolled in 2015, as part of the 4th intake, on the M.A. Olympic Studies programme and successfully completed the qualification in 2018. Since it was an initiative to establish an Olympic Studies Centre at the University of Johannesburg (UJOSC), it was decided to build capacity among staff and thus to rather obtain a formal qualification in Olympic Studies and then to develop and teach programmes on Olympic Studies in South Africa (SA) and perhaps abroad. His experience in and passion for Physical Education (PE), sport and the Youth of SA added positively towards his decision to embark on this venture. He however expressed the visits to the different countries, intercultural interaction and relationship development as his highlights during this study period.

Kobus is currently an Associate Professor and the Head of Department of the Sport and Movement Studies Department in the Faculty of Health Sciences at the University of Johannesburg (UJ), SA. He is also the Deputy Director of the UJOSC that was established in 2015. This Centre is the first on the African Continent and with the collaboration and support from the German Sport University (GSU) of Cologne, as consultants, various national and international initiatives and activities were conducted, and international colleagues were hosted by him and his colleagues at UJ.

He obtained various academic and professional qualifications from various Universities. All qualifications refer to Sport and Movement Education. He reinstated the training of PE Teachers at UJ and also developed a keen research interest in Adventure Education, Physical Education, Values Education and Adapted Sport and Physical Activity for People with Disabilities. Kobus has published widely and presented his research findings at various national and international conferences.

As part of his Master thesis entitled 'Ernst (1907-1997)and his contributions to Physical Education in South Africa', he had the opportunity work on archive material and collections in the GSU Cologne. He also interviewed the late) 97 year old Prof. Isabel Nel who

was a student of Jokl as well as a colleague of his at the University of Stellenbosch, SA, where he introduced the first degree in Physical Education in 1936.

A current interest and drive of Kobus is:

- 1. To assist with the renovation and completion of the UJSC own venue before the end of 2019.
- 2. To infuse Olympic Values, Olympism and late Nelson Mandela's life philosophy through 'Ubuntu' into the PE school curriculum.

He concluded: "May I take this opportunity to express my gratitude to all the lecturers for the great work and for sharing their knowledge and experience with so much passion. Also to all my Olympic Studies friends from all over the world who made all the 'get-togethers' so special – I salute you and really want to recommend this programme to all future leaders in sport!"
